Phase III in the eastern corridor of the Borough was constructed and is from Market Street through Community Park to the EASD campus. This project (Phase IIIA) will connect the existing pathway network with Elizabethtown College through the Elizabethtown Area School District campus. The proposed project consists of the construction of a bike-pedestrian pathway that will connect at the termination point of the existing trail located approximately 300 ft. east of South Chestnut Street and extend the pathway from that termination point on the Elizabethtown Area School District campus to the existing Kiwanis Boulevard stream crossing at Elizabethtown College. Additional work includes installation of lighting in the previously completed portion beginning at South Chestnut Street and continue to the existing Kiwanis Boulevard stream crossing/culvert. The pathway will be approximately 1050 feet in length and will be 6 ft in width. The surface composition will largely be asphalt with the use of a boardwalk in one section. This boardwalk is located at the extreme eastern end of the project where the pathway connects to Elizabethtown College stream crossing. The boardwalk is used to span a low-lying section of floodplain. The pathway and boardwalk are designed to meet all ADA requirements.
