

NOTICE OF PUBLIC REVIEW AND COMMENT PERIOD AND PUBLIC MEETING FOR THE
CONNECTS2050 DRAFT METROPOLITAN TRANSPORTATION PLAN, DRAFT 2025-2028
TRANSPORTATION IMPROVEMENT PROGRAM, AND RELATED DOCUMENTS FOR LANCASTER
COUNTY

The Lancaster County Metropolitan Planning Organization (MPO) for Lancaster County announces a 30-day public review and comment period from May 13 through June 12, 2024 for the Draft Metropolitan Transportation Plan (MTP), Draft 2025-2028 Transportation Improvement Program (TIP), and related documents. The MTP is a plan to meet the mobility needs of people and goods in Lancaster County over the next few decades. The TIP is a listing of federal, state, and some locally/privately funded highway, bridge, transit and miscellaneous transportation projects that are expected to move into/through the project development process over the next four years. Public involvement for the TIP is used to satisfy public involvement requirements for the Pennsylvania Department of Transportation Section 5307 program of transit projects.

On May 28, 2024 at 12:30 pm a public meeting will be held on the draft MTP, TIP, and related documents. The meeting will be held in Conference Rooms 102 and 104 on the first floor of the Lancaster County Government Center (150 N. Queen Street, Lancaster, PA 17603). At the end of the meeting, the Transportation Technical Advisory Committee (TTAC) will consider recommending adoption of these documents to the MPO and the MPO will consider adoption of them at its June 24, 2024 meeting, held in the same rooms and at the same Zoom link at 12:00 pm.

Public comments on the documents must be submitted in writing (email or mail) at any time prior to the end of the public comment period on June 12, 2024.
