February 27, 2023	MPO adopts 2025-2028 Transportation Improvement Program Selection Process
April 19, 2023	LCPD staff participate in Spring/Summer Planning Partners Call
May 31, 2023	PennDOT District 8 sends Bridge Unit bridge candidate recommendations (MOAP) to LCPD
June 15, 2023	PennDOT District 8 sends A-Team paving candidate recommendations to LCPD
June 22, 2023	LCPD, PennDOT District 8, and PennDOT Central Office staff hold initial program update coordination meeting
July 12, 2023	LCPD staff score candidates from PennDOT District 8
July 12, 2023	PennDOT District 8 and LCPD staff meet to discuss TIP scoring prior to August TTAC meeting
August 2, 2023	LCPD and District 8 staff meet to coordinate on carryover & candidate projects
August 9, 2023	LCPD staff sent outreach letter to municipalities for comment on project candidates and scoring process
August 28, 2023	LCPD and PennDOT District 8 staff present to TTAC on carryover projects, performance measures, project ranking and scoring discussions
October 23, 2023	LCPD and PennDOT District 8 staff present to TTAC on project ranking and matching funding sources to projects
November 3, 2023	PennDOT provides Environmental Justice conditions data (pavement, bridge, safety and transit, if available) to MPO/RPOs
November 27, 2023	LCPD and PennDOT District 8 staff present to MPO project ranking and matching funding sources to projects
December 20, 2023	LCPD and PennDOT District 8 staff present to TTAC EJ analysis; final project review and recommendation with funding
December 28, 2023	LCPD and PennDOT District 8 staff "Teams" call to discuss programing
January 10, 2024	LCPD and PennDOT District 8 staff "Teams" call to further discuss programing
January 22, 2024	TTAC recommends approval of air quality significant projects for conformity analysis
January 29, 2024	MPO approves air quality significant projects for conformity analysis

January 31, 2024	LCPD, PennDOT District 8, and PennDOT Central Office staff hold draft 2025 Program Review Meeting
February 29, 2024	LCPD, PennDOT District 8, and City of Lancaster staff coordination meeting for resurfacings that may benefit Environmental Justice communities
March 4, 2024	LCPD staff meet with Manor Township staff to discuss PA 741 Corridor needs and prioritization
April 15, 2024	TTAC recommends MPO approve the public comment process
May 6, 2024	MPO takes action to approve the Public Participation and Adoption Process
May 13, 2024	Public Review and Comment Period Opens
May 28, 2024	TTAC recommends adoption of 2025 TIP to MPO
June 12, 2024	Public Review and Comment Period Closes
June 24, 2024	MPO adopts 2025 TIP
